

# CONTRACT RIDER FOR THE JONES FAMILY SINGERS

## TECHNICAL SPECIFICATIONS

---

SPEC1. The PURCHASER agrees to provide a professional sound reinforcement system with the minimum specifications in the documents accompanying this rider. If any component of the attached technical rider can not be provided or if a substitution must be made PURCHASER must contact and inform JONES FAMILY SINGERS immediately.

SPEC3. In the event that backline is provided, the PURCHASER agrees to provide backline per JONES FAMILY SINGERS Rider. Absolutely no substitutions of equipment may be made without the consent of JONES FAMILY SINGERS. **BACKLINE LISTED ON SEPARATE BACKLINE SCHEDULE**

SPEC4. JONES FAMILY SINGERS shall receive a minimum of sixty minutes free of all disturbances onstage for the purpose of a sound check before the doors open, unless expressly agreed upon by venue/promoter and artist agent/management.

SPEC5. JONES FAMILY SINGERS and their personnel shall maintain 100% control of the production and presentation of the performance, which includes the following provisions:

- a. Audience recording on and off the sound board is permitted only if it is expressly granted by artist/management prior to performance.
- b. The volume of the performance, both onstage and through the house system, shall be determined exclusively by JONES FAMILY SINGERS (within the limits of equipment capacity).

SPEC6. The PURCHASER shall provide at least two stagehands to be available for load-in and load-out and during the performance.

SPEC7. The PURCHASER shall also provide parking space adequate for two large vans and one trailer, OR 1-45 foot Tour Bus with Trailer in close proximity to the stage and/or loading door.

# CONTRACT RIDER FOR THE JONES FAMILY SINGERS

## HOSPITALITY/ DRESSING ROOM

HOSP1. The following MUST be provided to JONES FAMILY SINGERS

- a. Twelve (12) hot, well-balanced meals (Dinner). Meals are to include entrée (Chicken – preferred, steak or fresh fish), vegetable, rice or pasta, dessert, coffee/tea, and condiments. A meal buyout of \$20 per person is an acceptable alternative to catered meal.
- b. Dressing Room to have the following READY AT LOAD IN:

HOSP2. The hospitality requirements must be available at the request of JONES FAMILY SINGERS or their personnel upon their arrival at the specified load-in time. If shower facilities are available, they are to be working, clean, and stocked with bath towels. **\*\*\* NO ALCOHOL IN GREEN ROOM PLEASE \*\*\***

HOSP3. The PURCHASER will furnish a comfortable, secure, and private dressing/green room. This room should be clean, dry, well-lit, heated or air conditioned, **to comfortably fit EIGHTEEN (18) people**. The rooms shall also be within easy access of clean and private (no public access) washrooms. The PURCHASER shall be solely responsible for the security of items in the dressing room, and shall keep all unauthorized persons (not approved by band members or band personnel) from entering said area. The dressing room shall be locked or guarded when JONES FAMILY SINGERS are on stage or away from the venue. A key for the dressing room if available shall be entrusted to JONES FAMILY SINGERS'S road manager for the duration of the night.

HOSP4. All hospitality items are to be charged to the performance budget, if applicable, at real cost, any other price structure that exceeds local retail value for these hospitality items WILL NOT be accepted at settlement.

## PAYMENT

PAYM1. All payments are to be made by cash, money order, or certified check as follows:

- a. Deposit must be sent according to the terms of the contract.
- b. The balance shall be paid by the PURCHASER to JONES FAMILY SINGERS'S representative not later than thirty minutes after the end of the presentation.

# CONTRACT RIDER FOR THE JONES FAMILY SINGERS

- PAYM2. If the full price agreed upon involves a percentage after break point, that break point represents the fixed total of all accepted expenses pertaining to this engagement. This figure is a maximum and must be verified by receipt and documentation of each expense at settlement.
- PAYM3. The PURCHASER shall first apply any and all receipts derived from the entertainment presentation to the payments required hereunder. All payments shall be made in full without any deductions whatsoever.
- PAYM4. JONES FAMILY SINGERS shall have the right to have a representative present in the box office at all times. Said representative shall have access to the box office records of the PURCHASER relating to the gross receipts of this engagement only.
- PAYM5. 20 Tickets should be reserved for JONES FAMILY SINGERS guest list. No more than 20 other guest or comp tickets can be issued by the buyer when the payment is tied to a percentage of the gross or where a Bonus is paid @ "X" tickets sold.

## HOTEL

- HOTL1. If PURCHASER is providing Rooms - Please provide six (6) Double Rooms (Two Beds Each Room) and Hotel should be located close to venue when possible, and should have a restaurant on-site, and provide room service. Examples of preferred hotels are: Courtyard Marriot, Holiday Inn Express, Hampton Inn, etc. If not providing hotel, please recommend or give any available venue discounts.

## MERCHANDISING

- MERC1. JONES FAMILY SINGERS shall have the right to sell all merchandise without any venue or buyer Commissions (100% to Artist). The PURCHASER agrees that no party, including the PURCHASER him/herself, will appropriate JONES FAMILY SINGERS'S name or likeness for any merchandising use whatsoever. This prohibition includes any and every type of poster or other novelty item intended for sale at the venue or elsewhere at any time, unless agreed on beforehand by PURCHASER and JONES FAMILY SINGERS'S representative.
- MERC2. The PURCHASER agrees to provide a clean, well-lit, and highly visible area suitable for merchandise sales, and will provide a sizable table or flat countertop area if available. JONES FAMILY SINGERS reserves the right to use their own representative for merchandise vending during the event

## WARRANTIES AND REPRESENTATIONS

- WARR1. A representative of the PURCHASER duly authorized to make any decisions pertaining to this engagement must be present at the place of performance from the time of JONES FAMILY SINGERS'S load-in through the time of their load-out and payment.
- WARR2. **No other performing artist of any kind is to appear before or after JONES FAMILY SINGERS'S performance as herein agreed without the express written approval of JONES FAMILY SINGERS or JONES FAMILY SINGERS'S representative. Similarly, no such artist will be contracted or advertised in conjunction with this performance in any way without said approval.**

# CONTRACT RIDER FOR THE JONES FAMILY SINGERS

- WARR3. In the event the PURCHASER refuses or neglects to comply with the material terms herein, and/or fails to make any of the payments as provided herein, JONES FAMILY SINGERS shall have the right to refuse to perform this contract and shall retain any amounts theretofore paid to JONES FAMILY SINGERS or its representative by the PURCHASER. The PURCHASER will, in this circumstance, remain liable to JONES FAMILY SINGERS for the full agreed price. In addition, if on or before the date of any schedule performance, the PURCHASER has failed, neglected, or refused to perform any contract with any other performer for any earlier engagement, JONES FAMILY SINGERS'S agent shall have the right to demand the payment of the guaranteed compensation forthwith. If the PURCHASER fails or refuses to make such payment forthwith, the agent shall have the right to cancel this engagement by notices to the PURCHASER to that effect. In such an event, said agent shall retain any amounts theretofore paid in his/her name to the artist by the PURCHASER.
- WARR4. *Force Majure* - JONES FAMILY SINGERS'S obligations hereunder are subject to detentions or prevention by sickness, inability to perform, accident, failure of means of transportation, Acts of God, riots, strikes, labor difficulties, epidemics, any act of public authority, or any other cause similar or dissimilar beyond their control. In this case, any deposits issued will be returned in full.
- WARR5. Should the PURCHASER cancel this engagement in any circumstance other than an Act of God or for a similar reason beyond the PURCHASER'S control, the PURCHASER shall immediately remit to JONES FAMILY SINGERS a certified check or money order in the amount of fifty percent (50%) of the full price agreed on by the parties.
- WARR6. The PURCHASER hereby warrants that he/she is of sound mind and legal age to enter into this binding contract.
- WARR7. This agreement shall be construed in accordance with the laws of the State of Texas and shall be deemed entered into in that state. Legal venue for any dispute hereunder shall be in Travis County, Texas.
- WARR8. In case of any conflict of terms, the terms contained within this Rider shall prevail over all others. All terms of this Rider are specifically accepted by the PURCHASER unless they are expressly waived by JONES FAMILY SINGERS or their representative. Such waiver shall be effective only if initiated by JONES FAMILY SINGERS'S representative. **Please note that none of the requirements of this Rider can be invalidated by the failure of artist personnel to advance the engagement with any member of the PURCHASER'S production staff.**
- WARR9. The PURCHASER warrants that JONES FAMILY SINGERS shall receive 100% star billing in any and all publicity released and in paid advertisements, including, but not limited to, program fliers, signs, and marquees. The correct billing for the artist, applicable in all promotional materials, is "**THE JONES FAMILY SINGERS**" and PURCHASER must ensure that the name is spelled correctly. PURCHASER must inform and agree upon any changes to 100% star billing information with JONES FAMILY SINGERS'S representative. JONES FAMILY SINGERS hereby authorizes PURCHASER to use artist's name and likeness to promote the performance. No further use is granted.

# CONTRACT RIDER FOR THE JONES FAMILY SINGERS

WARR10. JONES FAMILY SINGERS reserves the right to cancel engagements with a 60 day notice for: TV appearances, recording opportunities, or promotional/publicity responsibilities. In this case, any deposits issued will be returned in full.

WARR11. All schedules, if attached hereto, are hereby made integral elements of this contract.

# THE JONES FAMILY SINGERS

## 2014

### BACKLINE

DRUMS: DW, Yamaha or Ludwig Kit - 22" kick, one (1) 14x6.5" snare (metal) with stand, 12" rack tom, 16" floor tom on legs (no stand mount), three (3) boom cymbal stands, one (1) hi-hat stand, one (1) single kick pedal, drum rug, drum throne, Zildjian Cymbals Series K - 14" hats, 17" and 18" crashes, 20 or 22" ride.

BASS: Hartke, GK or Ampeg amp head. Hartke, GK or Ampeg speaker cabinets: 1 - 4X10 with 1 - single 15 or 1 - 8X10.

GUITAR: **Primary Choice** - Fender Twin Reverb (1965 reissue preferred). **Secondary Choice** - Roland JC-120. All amps **MUST** have working spring reverbs.

KEYBOARD: **Primary Choice** - Yamaha Motif ES6 or similar. **Secondary Choice** - Roland RD700 or similar.

PERCUSSION:

Congas: LP - 10", 11", 12 3/4" (3 total) with stands. Please include tuning wrench.

Bongos: LP - 4" and 6" with stands. Please include tuning wrench.

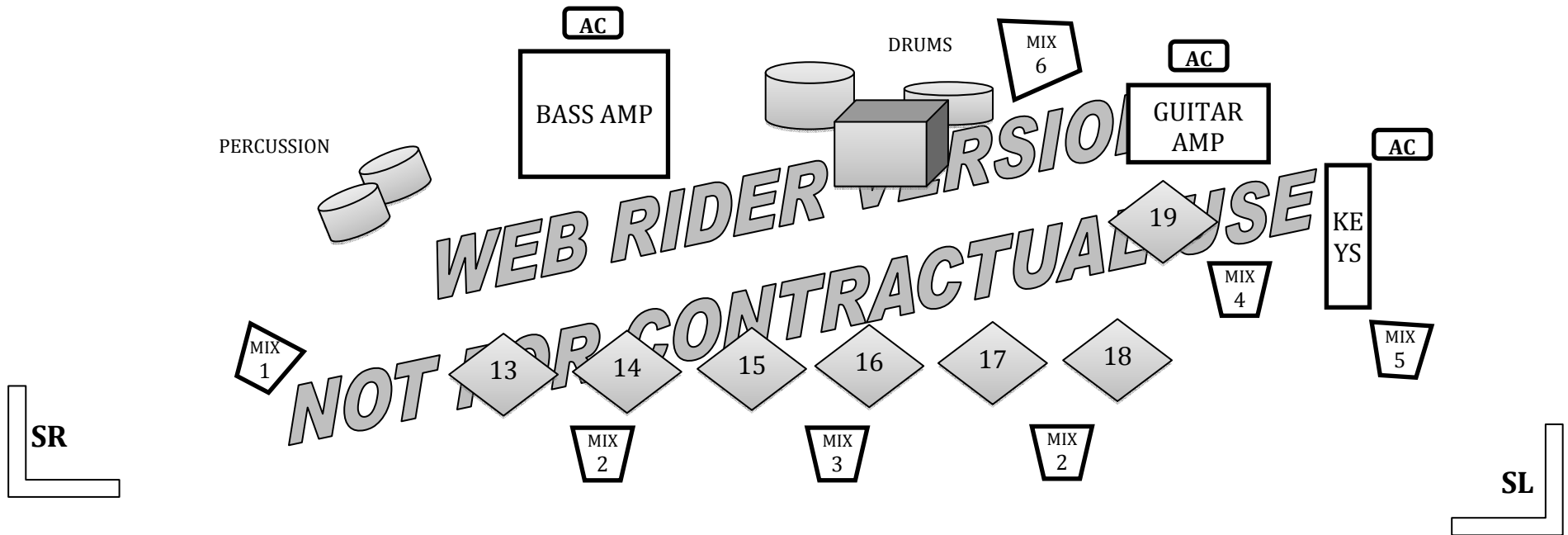
Timbales: One (1) pair LP timbales (two drums total - 10" and 12") with LP stand, plus two (2) additional boom cymbal stands. VERY IMPORTANT - the stand must have the "L" shaped mount that screws onto the top of the stand. Please include tuning wrench.

Table/Rack: For five to ten various hand percussion items, adjustable to standing height if possible.

MISC: Two (2) guitar stands, all necessary patch and speaker cables, plus 4 - 20' to 25' guitar cables.
